GS Trophy Try-Out Garmisch-Partenkirchen 2013 – Conditions of Entry

1.
The GS Try-Out Trophy 2013 Garmisch-Partenkirchen (hereinafter referred to as "Event") is an event designed for motorcycling enthusiasts who wish to practice or get to know the sporting challenge of the "GS" experience together with like-minded individuals (hereinafter referred to as "Participants"). There is particular emphasis on the fact that this is not a racing event.

The Event is organized by Bayerische Motoren Werke Aktiengesellschaft (Munich, Germany) (hereinafter referred to as "Organizer").

2.
The Event is not a timed competition as such but a test of mastery in which Participants have to undergo tests requiring a range of physical and mental skills and motorcycling ability.

3.
The Event does not include timed races as are common in motor racing.

4.
In order to take part in the competition, Participants must be prepared to subject themselves to challenges which go beyond everyday motorcycling. This includes dirt and mud situations as determined by the weather and as is usual in off-road sports. Therefore Participants have to be in a good physical, emotional and mental condition.

5.
Participants shall bring their own motorcycle of the type BMW GS, registered to the Participant, which shall be used for some of the tests. Participants shall also bring a complete enduro riders gear.

6.
Participation is free of charge. Registrations shall be served according to the time of entry until the Event is fully booked. The Event shall only take place if enough participants have registered.

Every Participant shall receive an acceptance letter or a letter of refusal until June 26th. There is no legal right to participation.

7.
Participants take part in the Event at their own risk. The Organizer shall only be liable for damage caused deliberately or in gross negligence by the Organizer or his vicarious agents or by breach of material obligations (obligations inherent in the content and purpose of the contract or whose fulfillment makes the execution of this Agreement possible and on which the User trusts or may trust), as well injury to life, body and/or health.

8.
The Participant shall indemnify the Organizer from all third party claims in connection with bodily or material damage caused by the Participant or vehicles used by the Participant in the course of the Event insofar as the third-party liability insurance of the Organizer does not assume liability for the damage. . This does not apply to product liability claims.

The Participant shall indemnify the Organizer against any and all claims deriving from a breach of statute, regulations or other provisions in connection with the use of the vehicle by the Participant or a third party. In the event that a claim is made against the Organizer, Organizer shall be entitled to make payment and to resort to the User for recourse.

Participants shall compensate the Organizer for any damages resulting from the assertion of such claims. This includes costs of prosecution.

9.
If the Organizer is entitled to make changes to the Event program or to cancel or terminate the Event due to force majeure or official directive or for safety reasons, the Organizer is not liable to the Participant for damages in any way.

10.
Participants consent to any photographs, films and interviews made in connection with their involvement in the Event being distributed and published on the radio, television, internet, print media, books and by means of photomechanical reproduction without claim to remuneration, including publication for advertising purposes. No personal details may be passed on to third parties with the exception of companies belonging to the BMW Group. If Participants wish to lodge an objection to the processing or use of their details at a later stage, they may do so free of charge.

11.
All Participants must be of age when submitting the registration form.

12.
By submitting the registration form, Participants agree to abide by the conditions of entry.

13.
If any of these provisions are or become invalid, the remaining provisions shall unaffected.

14.
This contract shall be governed by German law. Munich shall be the exclusive place of jurisdiction for any and all disputes arising from or in the context of this contract for both parties, unless a different place of jurisdiction is bindingly prescribed by law.
